## Measurement and data


The diagram shows the range of greenhouse gases – although carbon is a focus.

- Scope 1 Direct Organisations own direct fuel consumption
- Scope 2 Indirect Organisations use of grid energy
- Scope 3 Indirect Use of an organisation's supply chain and employees. Also, in its delivery


